A) **Functions and Responsibilities of the Committee**

1. JDS/DDS/DS of FCS&CA Deptt will be the (convenor of the Committee and shall remain responsible for convening the Committee's meetings.
2. The Committee shall sit once in three months ie. From 21st to 30th April, July ,Oct & January.
3. The meetings should be held in the office of the Deputy Commissioner concerned.
4. The Committee will review the over all functioning of the TPDS/ PDS Scheme in the District including Randhanjyoti, AAY , Grain Banks Scheme , MMASY retc and reports/suggestions of Sub-Divisional level, and Constituency level V&MC, discuss problems / difficulties / complaints/grivances etc. raised at the level of F.P.Shops /GPSS / Town Wholesale Consumer Co-operative Society/S.K.oil Retailer/ Sub- Wholesaler/Wholesaler/Gas Agencies and ensure disposed of these at the Committee level to the maximum possible extent and refer the undecided issues to the Director, FCS&CA and to the Govt. of Assam, FCS&CA Deptt for appropriate action.
5. The Committee will examine and ensure the timely lifting & distribution of all PDS/TPDS items in the District as per norms on the basis of Sub-allocations received from Director FCS&CA Assam.
6. The Committee will review the stock and delivery of PDS/TPDS items by FCI and also examine and review the functions of S.K.Oil Depot/ Sub-wholedepot/retailers/hawkers of the District.
7. The Committee will suggest measures to streamline the PDS towards making it more transparent and really beneficial to the people, the schemes are meant for and propose appropriate action.
8. Examine Mise relevant matters.

B) Functions and Responsibilities of the Committee

1. Sr. Most FCS&CA Deptt officer of the constituency will be the Convener of the Committee and shall remain responsible for Convening the Committee's meetings quaterly i.e in April, July, Oct & January
2. The committee will have to sit once in three months i.e from 1st to 7th of concerned month.
3. The Meeting should be held preferably, in the DCs/SDO (C) office or other public institutions.
4. The Committee will ensure timely lifting and delivery of all TPDS/ PDS items from FCI and despatch of the items to the FP Shops falling under the Constituency.
5. The Committee will ensure the delivery of PDS S,K,Oil from the storage of GPSS itself to Agents/FP Shops without authorizing to lift it from S.K.Oil Sub-Wholesale/Wholesale depot.
6. The Committee will depute one member on rotation basis to FCI/S.K Oil Depot/Sub-Wholesale depot at the time of taking delivery of S.K.Oil.
7. The Committee shall examine the report submitted by FP Shops level V&M Committee/take action and dispose it and if necessary send it to District/Sub-Divisional level V&M Committee with comments.
8. Any genuine grievance/complaint and difficulties of the FP Shops owners /Agents will be examined/disposed of and if required be sent to SDLV&M Committee with its recommendation.
9. The Committee will examine and suggest measures to streamline and improve the system towards making it more transparent within the legal frame work.
10. Misc relevant matters.
