

PROCEEDINGS OF THE MEETING OF THE DISTRICT LEVEL VIGILANCE AND MONITORING COMMITTEE : KARIMGANJ HELD ON 24-12-2009 AT 11 AM AT THE CONFERENCE HALL OF D.C.'s OFFICE, KARIMGANJ.

Members present :- As per list vide Annexure-A.

The meeting was chaired by Sri L.M. Suklabaidya, Hon'ble M.P., H.P.-1, Karimganj and the Chairman, District Level Vigilance and Monitoring Committee, Karimganj District.

Initiating the discussion, the hon'ble M.P. and the Chairman of the Committee requested Dr. M. Angamuthu, IAS, Deputy Commissioner, Karimganj to enlighten the house about the status of the works under various schemes of the different Departments in the District.

Joining the discussion the Deputy Commissioner, Karimganj impressed upon the Officers of different Departments present to table the achievement and progress of the works of different schemes under their Departments.

First of all, the house wanted to know about the present position of the fund received from 12th Finance Commission from the Chief Executive Officer, Karimganj Zilla Parishad. In reply the C.E.O., KZP tabled in the meeting that the fund received from the 12th Finance Commission had been utilized to a great extent & the balance amount of fund would be utilized soon. Taking part in the discussion, Hon'ble M.P., Karimganj & Chairman of the Committee opined that the list of total beneficiaries of all schemes should be provided to all the members of the committee by the Departments concerned. In course of discussion regarding the fund position of the 12th F.C. being raised by some of the members, the Deputy Commissioner, Karimganj assured the house that the C.E.O., KZP would submit papers on this issue to the Deputy Commissioner, Karimganj for appraisal of the hon'ble members.

The hon'ble MP, Karimganj & Chairman of the committee and also the Deputy Commissioner, Karimganj desired to know the progress of the construction of different roads of the district under PMGSRY. In response, the Executive Engineer, PWD (Rural Roads), Karimganj apprised the house that works of some schemes (Roads) had already been started & some were yet to be started. Sri Mission Rn. Das, hon'ble MLA, North Karimganj also joined in the discussion. Hon'ble MP, Karimganj & Chairman also pointed out some specific roads like Anipur-Durlavcherra Road, Katamoni-Balia Road, Kalkalimukh-Pachim Defalala Road, Kanaibazar-Sonatola Road, Duhalia-Binodini Road & wanted to know the status of the works. In reply the EE concerned stated that the works of those roads would be completed soon. In this context he pointed out that shortage of forest materials in one hand and labourers on the other due to ongoing harvesting season were deterring the progress of the works. Taking part in discussion, the Deputy Commissioner, Karimganj agreed that the shortage of Forest materials was a factor hindering the pace of the works. But, he directed the EE, PWD (R/R) Karimganj to complete the works as early as possible and said that all works should be complete within 1 (one) year and should not linger for 4/5 years. He also assured to request the Divisional Forest Officer (T), Karimganj to help solve the problem of shortage of forest materials.

Discussing regarding the works of the PHE Department, the Deputy Commissioner, Karimganj wanted to know about the drinking water facilities in the quality affected habitation & the steps being taken by the Department to tackle the situation. In reply, the departmental representative Sri Joydeb Nath, AEE, stated that there were 639 such quality affected areas in the District & the PHE was taking all feasible & permitted measures to cover those habitations to provide safe drinking water. The Deputy Commissioner, Karimganj quoting the Govt. decision to supply drinking water to all human habitations of the Country by 2011 asked the PHE Department

to cover all the uncovered areas of the District in general & those quality affected areas in particular by 2011 & also to submit an action plan in this regard before the next meeting. Taking part in the discussion, hon'ble MP & Chairman wanted to know about the defunct plants & as to whether these can be made functional. The departmental representative said in reply that, there had been no departmental fund to maintain/repair those defunct plants. The Deputy Commissioner, Karimganj also admitted that there was no such fund at the disposal of the Department to make the defunct schemes functional. And he requested the CEO, Karimganj Zilla Parishad to tie up with PHE department & find out ways & means for funding the defunct schemes from the fund of Zila Parishad for their revival. Hon'ble MP & Chairman also expressed his willingness to place fund for this purpose out of his Local Area Development Fund. Accordingly, the Deputy Commissioner, Karimganj & hon'ble MP & Chairman instructed the PHE Department (E.E. P.H.E., Karimganj Division) to conduct a survey to identify the defunct plants of the District & prepare & submit a comprehensive report/ plan & estimate immediately with a view to make those plants operational.

In regard to the DRDA, Karimganj the Project Director, DRDA, Karimganj took part in the discussion and appraised the house with the statistics of facts & figures about the different schemes including NREGA etc. being executed by the Agency. Regarding Horioli scheme the PD informed the house that the said scheme had been transferred to the Soil Conservation Division. Participating in the discussion, the hon'ble MP & the Chairman desired to know the fund position. The PD, DRDA, Karimganj apprised the fund position & the Deputy Commissioner, Karimganj informed the house that, all steps had been taken to divide the available fund Development Block wise evenly & execute the schemetic works as soon as the approval would be received. The Deputy Commissioner, Karimganj also instructed the PD, DRDA, Karimganj to utilize the SHG, Evolving etc. funds fully & bring the balance to nil. Taking part in the discussion, hon'ble MLA Badarpur pointed out that if the fund would be utilized Development Block wise, there may be some difficulties for the L.A. Segments. In reply the Deputy Commissioner, Karimganj assured that, though as per norms schemes would have to be taken Development Block wise but, special care would be taken to pay optimum attention to Assembly segment wise Gaon Panchayats.

In course of discussion regarding Minority Development Fund of the District as initiated by hon'ble MP & Chairman, the Deputy Commissioner, Karimganj informed that, the fund would be utilized properly as per Govt. directives & guidelines and to formulate the modelities of selecting the beneficiaries and other connected matters a separate meeting would be held.

During special discussion regarding IAY wait list, the Deputy Commissioner, Karimganj referring to the standing Govt. decision in this regard, said that the Gaon Sabha in its meeting may remove the undeserving names of beneficiaries from the wait list and also made it clear that selection of the beneficiaries would have to be made from among the enlisted beneficiaries of the wait list & not out side the wait list.

At the end the, Deputy Commissioner, Karimganj instructed the District Heads of all District Offices / Departments to ensure completion of all schemetic works within the targeted period, without any delay & deviation, whatsoever. Further, he directed the Block Development Officers of the District to hold Block Level Vigilance & Monitoring Committee meeting as per guidelines. He also asked each of the District Heads of Offices to submit 25 (Twenty five) copies of physical & financial progress report of their respective Departments in folder files at least 10 (Ten) days ahead of the next meeting of the D.L.V. & M.C. so that the same can be provided to the hon'ble Members welahead as also desired by the hon'ble MP, Karimganj & Chairman of the Committee.

Thereafter, the meeting ended with a vote of thanks from and to the Chair.


